Welcome to the **Option B Report & Recommendations Portal** for the North Carolina opioid settlements, where a local government may submit a PDF copy of a Report & Recommendations (R&R) resulting from a collaborative strategic planning process.

Under Option B of the Memorandum of Agreement (MOA), a local government that first undertakes a collaborative strategic planning process resulting in an R&R to the local governing body may then select one or more strategies from the shorter list of Exhibit A strategies or from a longer list of strategies included in the national opioid settlements.

Under the terms of the MOA, a local government cannot select a strategy from the longer list of strategies included in the national opioid settlements without first undertaking the collaborative strategic planning process resulting in the R&R to the local governing body. (By contrast, a local government may select a strategy from the shorter list of Exhibit A strategies with or without the collaborative strategic planning process.) **Once the R&R are submitted to the county board, city council, or other local governing body for consideration, the local government then has 90 days to upload a PDF copy of the R&R to this portal.
